Dear Prospective Candidate,

Thank you for taking the first step in consideration of a position for public office with the City of Glenn Heights. Your candidacy entails the obligation to comply with certain applicable state statutes, charter provisions, and local ordinances. In an effort to assist you with these requirements, I have prepared this Candidate Packet with necessary forms, pertinent information, and basic instructions. You are encouraged to read this letter and the enclosed material carefully prior to filling out any forms or filing for office.

This year, the positions of Mayor and Council Member Place 2, Place 4, and Place 6 will be elected in the General Election. All Places are At-Large – Glenn Heights does not have Districts. All candidates for office must be citizens of the United States, have lived within the State for a minimum of one year, be a resident of Glenn Heights, Texas for one year, and be a minimum of 18 years of age. You must also be a registered voter of the State of Texas, in Dallas County or Ellis County.

It is the candidate's responsibility to become familiar with the laws applicable to campaigning for office. This office will advise you of upcoming filing dates upon request; however, the role of the City Secretary is limited to accepting and filing the various forms, applications, affidavits, and/or statements, and noting the date and time of the filing thereon. **This office should not be expected to comment upon the timeliness or sufficiency of reports filed.** Should you have any questions regarding reporting procedures, contributions, or expenditures, please call the Texas Ethics Commission at (512) 463-5800 or visit www.ethics.state.tx.us. Additionally, all complaints, concerns, and violations regarding campaign practices should be reported to the Texas Ethics Commission, and not your local municipality. Signage in violation of municipal ordinances may be reported to the Glenn Heights Code Enforcement Division at (972) 274-5100.

You may direct questions about election laws to the Secretary of State at (800) 252-8683 or (512) 463-5650, or visit www.sos.state.tx.us.

The filing period for a place on the November 4, 2025, ballot begins July 19, 2025, and will continue through August 18, 2025, **during the City Secretary's regular business hours, Monday – Friday, 8:00 A.M. – 5:00 P.M.** You may also file your forms by mailing them to City Secretary's Office, 1938-C S Hampton Road, Glenn Heights, TX 75154,

emailing them to brandi.brown@glennheightstx.gov, or faxing them to (972) 274-3602. These documents must be received by 5:00 P.M. on the deadline date and be fully filled out, **notarized**, and signed. The City Secretary's Office will not notarize documents.

I have attached the following forms/ documents in this Candidate Packet:

1. **Application for a Place on the Ballot (required)** – Each candidate must file this form with the Office of the City Secretary in order to have their name placed on the ballot. This form must be filed during regular business hours. There is no filing fee. Each application will be reviewed to determine whether it complies with the Election Code requirements as to form, content, and procedure. Please file your application as soon as practicable to allow sufficient time for review. Copies of your submitted forms must be made by the candidate prior to filing with the City Secretary's Office.

Your application will be posted on the city's website once you become a qualified candidate. Pursuant to Government Code Sec. 552.101, dates of birth will be redacted and you will be given the option to protect your phone numbers and email addresses. We do suggest having a contact number or email address open to the public, as we point to the application online when asked by citizens how to reach candidates.

2. **Appointment of a Campaign Treasurer by a Candidate (Form CTA) (required)** – The Form CTA should be filed with the City Secretary before/or at the same time as you file the application for a place on the ballot, and/or before you make any expenditures or accept any contributions.
3. **Candidate/Officeholder Campaign Finance Report (Form C/OH) and Texas Ethics Commission 2025 Filing Schedule**
4. **Code of Fair Campaign Practices Form (CFCP) (recommended but not required)** – By signing this form you are signifying your intentions to run a fair, ethical, and honest campaign. This form is voluntary; however, it is highly recommended that you sign it and file it with the City Secretary at the same time as you file your application for a place on the ballot and the Form CTA.
5. **City of Glenn Heights Official's Financial Disclosure Statement**
6. **Election Calendar**

Forms filed which are illegible or are incomplete will be considered insufficient. Please proof-read all documents before submitting them to the City Secretary's Office for review.

Upon submission of your application for a place on the ballot, all forms become the possession of the City of Glenn Heights. Please be aware that Sec. 254.036(a) of the

Election Code requires that all forms pertaining to financial reporting be written in black ink or typed with black typewriter ribbon, unless the report is a computer printout. If the report is a computer printout, the printout must conform to the same format and paper size as the form prescribed by the commission. I would also like to emphasize the importance of adhering to the financial reporting procedures. Campaign reports are considered open records; therefore, they are subject to the Texas Public Information Act and will be made available for review by the general public, reporters, and opponents alike. Additionally, per Election Code Sec. 141.034(a), "an application for a place on the ballot may not be challenged for compliance...after the 50th day before the date of the election..." Per Election Code Sec. 141.034(c), "a challenge must state with specificity how the application does not comply with the applicable requirements as to form, content, and procedure. The authority's review of the challenge is limited to the specific items challenged and any response filed with the authority by the challenged candidate."

The City of Glenn Heights Charter will provide each candidate with an overview of the roles and responsibilities provided to the elected and appointed officials of the City of Glenn Heights. The City Charter may be found on the City's website at <https://ecode360.com/GL6320>.

The City Secretary's Office is open to help you and will assist you as best possible with your questions and needs. Your interest in municipal government is appreciated, and I hope that this will be a positive and exciting experience for you. NEPOTISM LAW

The candidate must sign this statement indicating his awareness of the nepotism law. When a candidate signs the application, it is an acknowledgment that the candidate is aware of the nepotism law. The nepotism prohibitions of chapter 573, Government Code, are summarized below:

No officer may appoint, or vote for or confirm the appointment or employment of any person related within the second degree by affinity (marriage) or the third degree by consanguinity (blood) to the officer, or to any other member of the governing body or court on which the officer serves when the compensation of that person is to be paid out of public funds or fees of office. However, nothing in the law prevents the appointment, voting for, or confirmation of anyone who has been continuously employed in the office or employment for the following period prior to the election or appointment of the officer or member related to the employee in the prohibited degree: six months, if the officer or member is elected at an election other than the general election for state and county officers.

No candidate may take action to influence an employee of the office to which the candidate is seeking election or an employee or officer of the governmental body to which the candidate is seeking election regarding the appointment or employment of a person related to the candidate in a prohibited degree as noted above. This prohibition does not apply to a candidate's actions with respect to a bona fide class or category of employees or prospective employees.

LEY DE NEPOTISMO

El candidato debe firmar esta declaración indicando su conocimiento de la ley del nepotismo. Cuando un candidato firma la solicitud, es un reconocimiento de que el candidato conoce la ley del nepotismo. Las prohibiciones de nepotismo del capítulo 573, Código de Gobierno, se resumen a continuación:

Ningún funcionario puede nombrar, votar o confirmar el nombramiento o empleo de cualquier persona emparentada dentro del segundo grado por afinidad (matrimonio) o del tercer grado por consanguinidad (sangre) con sí mismo, o con cualquier otro miembro del órgano de gobierno o corte en el que se desempeña cuando la compensación de esa persona debe pagarse con fondos públicos o honorarios del cargo. Sin embargo, nada en la ley impide el nombramiento, la votación o la confirmación de cualquier persona que haya estado empleada continuamente en la oficina o el empleo durante el período siguiente antes de la elección o el nombramiento del funcionario o miembro emparentado con el empleado en el grado prohibido: seis meses, si el funcionario o miembro es elegido en una elección que no sea la elección general para funcionarios estatales y del condado.

Ningún candidato puede tomar medidas para influir en un empleado del cargo al que aspira a ser elegido o en un empleado o funcionario del organismo gubernamental al que aspira a ser elegido en relación con el nombramiento o el empleo de una persona emparentada con el candidato en un grado prohibido, tal como se ha indicado anteriormente. Esta prohibición no se aplica a las acciones de un candidato con respecto a una clase o categoría de buena fe de empleados o empleados prospectos.

Candidates and officeholders must file semiannual reports (due on January 15, 2025, and July 15, 2025). In addition, a candidate who has an opponent on the ballot in an election held on a uniform election date must file two pre-election reports (unless the candidate has elected modified reporting).

The campaign treasurer of a political committee that is involved in an election held on a uniform election date must also file pre-election reports (unless the committee is a general-purpose political committee that files monthly or a specific-purpose political committee that files on the modified reporting schedule). This schedule sets out the due dates for pre-election reports in connection with elections on uniform election dates. Please consult the 2025 REGULAR FILING SCHEDULE FOR GENERAL-PURPOSE POLITICAL COMMITTEES (GPAC), COUNTY EXECUTIVE COMMITTEES (CEC), AND SPECIFIC-PURPOSE POLITICAL COMMITTEES (SPAC) for a complete listing of political committee deadlines.

Candidates for and officeholders in local offices regularly filled at the general election for state and county officers (the November election in even-numbered years) should use the 2025 FILING SCHEDULE FOR CANDIDATES AND OFFICEHOLDERS FILING WITH THE COUNTY CLERK OR ELECTIONS ADMINISTRATOR.

EXPLANATION OF THE FILING SCHEDULE CHART

COLUMN I: REPORT DUE DATE - This is the date by which the report must be filed. If the due date for a report falls on a Saturday, Sunday, or legal holiday, the report is due on the next regular business day. This schedule shows the extended deadline where applicable. A report transmitted to the Texas Ethics Commission over the Internet is considered timely filed if it is transmitted *by midnight, Central Time Zone, on the night of the filing deadline*. For most filing deadlines, a report filed on paper is considered timely filed if it is deposited with the U.S. Post Office or a common or contract carrier properly addressed with postage and handling charges prepaid, or hand-delivered to the filing authority by the filing deadline. **Pre-Election Reports:** A report due 30 days before an election and a report due 8 days before an election must be *received* by the appropriate filing authority no later than the report due date to be considered timely filed.

COLUMN II: TYPE OF REPORT (WHO FILES) - This column gives the report type and explains which reporting form to use and which filers are required to file the report.

COLUMN III: BEGINNING DATE OF PERIOD COVERED - This column sets out the beginning date of the time period covered by the report. Use the latest one of the applicable dates. The "date of campaign treasurer appointment" is the beginning date only for the *first* report filed after filing a campaign treasurer appointment. For officeholders recently appointed to an elective office, the beginning date for the first report will be the date the officeholder took office, provided that he or she was not already filing as an officeholder or candidate at the time of the appointment. (*NOTE: If you are ever confused about the beginning date for a required report, remember this rule: **There should never be gaps between reporting periods and, generally, there should not be overlaps.***)

COLUMN IV: ENDING DATE OF PERIOD COVERED - This column sets out the ending date of the time period covered by the report. The report must include reportable activity occurring on the ending date.

CODE OF FAIR CAMPAIGN PRACTICES

There are basic principles of decency, honesty, and fair play that every candidate and political committee in this state has a moral obligation to observe and uphold, in order that, after vigorously contested but fairly conducted campaigns, our citizens may exercise their constitutional rights to a free and untrammelled choice and the will of the people may be fully and clearly expressed on the issues.

THEREFORE:

- (1) I will conduct the campaign openly and publicly and limit attacks on my opponent to legitimate challenges to my opponent's record and stated positions on issues.
- (2) I will not use or permit the use of character defamation, whispering campaigns, libel, slander, or scurrilous attacks on any candidate or the candidate's personal or family life.
- (3) I will not use or permit any appeal to negative prejudice based on race, sex, religion, or national origin.
- (4) I will not use campaign material of any sort that misrepresents, distorts, or otherwise falsifies the facts, nor will I use malicious or unfounded accusations that aim at creating or exploiting doubts, without justification, as to the personal integrity or patriotism of my opponent.
- (5) I will not undertake or condone any dishonest or unethical practice that tends to corrupt or undermine our system of free elections or that hampers or prevents the full and free expression of the will of the voters, including any activity aimed at intimidating voters or discouraging them from voting.
- (6) I will defend and uphold the right of every qualified voter to full and equal participation in the electoral process, and will not engage in any activity aimed at intimidating voters or discouraging them from voting.
- (7) I will immediately and publicly repudiate methods and tactics that may come from others that I have pledged not to use or condone. I shall take firm action against any subordinate who violates any provision of this code or the laws governing elections.

I, the undersigned, candidate for election to public office in the State of Texas or campaign treasurer of a political committee, hereby voluntarily endorse, subscribe to, and solemnly pledge myself to conduct the campaign in accordance with the above principles and practices.
